Information about the service

Inbound 1300/1800

1300 numbers are virtual business numbers that can be called for as low as the cost of a local call. These numbers receiving incoming calls and redirect them to an existing phone line (answer point) such as mobile or landline.

Smart Numbers

Smart numbers are distinctive phone numbers that are considered the best 13,1300,1800 numbers available. These inbound numbers come in the form of phone words which spell out your business name or service e.g., 1300 UPLINK (1300 875 465), and numbers that come in repeating or sequenced numerical patterns e.g., 1300 20 30 40.

Your Existing Voice Service

If you have an existing voice service with The Uplink Telecom or another provider, moving to Inbound 1300/1800, you will have to cancel your existing service. To retain the existing phone number, you must fill and sign a Porting Application Form (PAF). You also need to provide details of your existing carrier such as

- Details of all the numbers you wish to transfer to The Uplink Telecom.
- Current or latest bill of the existing provider showing all the phone numbers you wish to transfer.

Fair Use Policy

You must comply with our Fair Use Policy and not use your services in an unreasonable or fraudulent manner or in a way that detrimentally interferes with the integrity of the network. We may take action if you breach the Fair Use Policy, including suspending or cancelling your service, or reducing its speed.

Understanding my bill

Your bill is issued on the same date each month. You're billed in advance for the minimum monthly charge, and in arrears for any usage not included in your plan. You may also be charged for individual services until all those in your plan are connected, so your first few bills may be higher or lower than expected. When you start or change your plan part way through a billing period, your first bill will have additional charges.
