

Privacy Policy

We respect your privacy.

- Vire Networks Pty Ltd T/A The Uplink Telecom respects your right to privacy and is (a) committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth). This policy sets out howwe collect and treat your personal information.
- "Personal information" is information we hold which is identifiable as being about (b) you.

Collection of personal information 2.

- (a) Vire Networks Pty Ltd T/A The Uplink Telecom will, from time to time, receive and store personal information youenter onto our website, provided to us directly or given to us in other forms.
- (b) You may provide basic information such as your name, phone number, address, and email address to enable us to send information, provide updates and process your product or service order. 3. How we collect your personal information

Use of your personal information.

5. Disclosure of your personal information

- (a) We may disclose your personal information to any of our employees, officers, insurers, professional advisers, agents, suppliers, or subcontractors insofar as reasonably necessary for the purposes set out in this Policy. Personal information is only supplied to a third party when it is required for the delivery of our services.
- (b) We may from time to time need to disclose personal information to comply with a legal requirement, such as a law, regulation, court order, subpoena, warrant, in the course of a legal proceeding or in response to a law enforcement agency request.
- (c) We may also use your personal information to protect the copyright, trademarks, legal rights, property, or safety of Vire Networks Pty Ltd T/A The Uplink Telecom, www.theuplink.com.au, its customers or third parties.
- Information that we collect may from time to time be stored, processed in, or (d) transferred between parties located in countries outside of Australia. These may include but are not limited to India.
- (e) If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances.

Where we disclose your personal information to third parties, we will request that the third party follow this Policy regarding handling your personal information.

6. Security of your personal information
